



Report of the Director November 2024

David Archer, Library Director

NVDA

All public and staff computers have been installed with NonVisual Desktop Access (NVDA), a free and open-source screen reading software audibly read what is on the screen by converting the text to synthesized speech and help the user navigate computer applications and websites.

NVDA allows patrons with visual impairments better access to our computers. Having it on staff computers helps us understand first-hand how these tools are used and gives us the capability to test and ensure our website and online resources are accessible.

Cook Park Server Room Air Conditioner Replacement

The dedicated air conditioning unit for the Cook Park server room recently malfunctioned and required service. Upon evaluation, it was determined that the unit was beyond repair. A replacement unit was recommended. The existing unit was installed in 2001 and was scheduled to be replaced in 2026, according to the previous capital needs assessment. The server room has been temporarily cooled by a portable unit, which has not maintained optimal temperatures.

Although the FY25 budget did not include this expense, and the replacement cost exceeds the director's spending limit of \$10,000 as outlined in the Purchasing Goods and Services Policy, emergency repairs and equipment replacements can proceed without prior Board or Committee approval. The Board President was informed of the need to expedite this purchase as an emergency.

Two quotes were obtained for installation of a 3-ton Mitsubishi PUY-A36 split system cooling outdoor unit, as recommended by our I.T. contractor. Sherman Mechanical provided the lower quote, which was accepted, and the new unit is scheduled for installation on Thursday, November 21. As this is a capital expense, the AC unit will be purchased with funds from the Special Reserve Fund.

Narcan

We have partnered with the Lake County Health Department to keep Naloxone (Narcan) available at both library locations for emergency use by trained staff. Naloxone is a non-addictive, life-saving medication that can reverse the effects of an opioid overdose when administered promptly. Through this partnership, Narcan has been provided to us free of charge, and select staff members who have volunteered will receive training from the Health Department on November 21. Our local first responders recommended having Narcan on-site.

- 1. CMPLD's new **Seed Library** got off to a great start. From September 15 to October 15, patrons donated over seven hundred seed packets! Several seed companies also contributed seeds. All donations will ultimately be repackaged into smaller envelopes over the winter and offered at the opening of the Seed Library in March 2025.

- 2. On November 4, Brooke Bahnsen, Outreach Manager, and Frida Hernandez, Aspen After-School Associate, participated in the **Día de los Muertos (Day of the Dead)** event hosted by the Hawthorn 73 Bilingual Parent Advisory Committee. Brooke and Frida set up a table with crafts for children and information about the library. More than 200 families attended the event, and Brooke and Frida interacted with more than 80 children and their families. Brooke and Frida both speak Spanish, so they were able connect with families in the language with which they are most comfortable. -- Melissa Phillips, Senior Manager of Children's Services
- 3. **Rebeccah Jensen**, Children's Library Assistant, has started her first semester in the Master of Library Science program at Valdosta State University in Georgia. Rebeccah is enrolled in the remote learning program at the school. Rebeccah oversees several important activities in the Children's, including the selection of world languages materials. Her participation in the MLS program will undoubtedly bring new perspectives and ideas to the Children's Department. -- MP
- 4. Children's Services recently launched a set of **sensory kits** for use in the Library. The kits contain a variety of tools designed to help patrons with sensory needs have an enjoyable and welcoming experience while visiting the library. The kits are also useful to caregivers who are trying to help their young children regulate their emotions. Each kit contains noise-canceling headphones, tinted glasses, weighted lap pads, sensory seats, and a variety of fidgets and sensory-friendly toys. Since their launch last month, the kits have been in heavy rotation at both locations, with patrons commenting how helpful they found the kits. The kits were developed by Heather Beverley, Assistant Manager of Children's Services, with input from other Children's staff. -- MP
- 5. In November, staff from the early learning team in Children's Services celebrated the end of the fall **Super Readers program**, visiting 14 early learning centers. The program serves more than 800 children in 60 classrooms. The Super Reader program is designed to bring the seasonal reading clubs out of the library into the early learning centers to allow those students to participate. Library staff presenting at the early childhood centers were Vijaya Char, Maura Czerwinski, Deena Gillespie, and Emily Schultz. –*MP*
- 6. As part of **Goal D4 of the Strategic Plan**, Katie DuClos, Bronwyn Sill, Lindsay Barber-Peddycoart, and Amy van Goethem are striving to enhance internal communications and share the Library's story. The October and November TREAT 'n' Meets were very informative. Nicole Bosak and Sandy Kline spoke about their work in Acquisitions, and Jenny Barry presented an overview of Local History, including a mini tour of the Cook House afterwards. Since the Cook Park Meeting Room won't be available for a few months, we're moving TREATS 'n' Meets online. We're hoping to have one online offering each month, from December through April. The 3 Treats Newsletter will continue to share communication tips, library news, and highlight staff members during this time.

- 7. Cyndi Hamann, Collection Development Manager suggested a **local subject heading** for our Library of Things collection. Esther Lang, Head of Cataloging, implemented the suggestion and now one can quickly search for all items in our <u>Library of Things</u>.

- 8. Amy Heatherman, Interlibrary Loan Librarian and ILS Administrator, and Katie DuClos, Technical Services Manager, deleted all 99,000+ hoopla records. We are doing this with one eMaterial service each year to keep the catalog records for these services as accurate as possible. -- KD
- 9. On October 28th Darek Makowski hosted the Paczki & Pictures program at Aspen. 26 patrons viewed and learned more about the classic Polish film CONQUEST starring Greta Garbo and Charles Boyer. We were pleased with the turnout and happy to share world language materials with patrons who may not usually check them out.

Allie Mendelson, Information Services Librarian, has renewed CMPLD's partnership with D128's Transition Pathways, a program which works to improve educational, functional, and vocational readiness for students with disabilities. We now have a student volunteer coming in weekly. Thanks to the willingness of other departments to collaborate, the volunteer will complete a variety of tasks, including tidying shelves and cutting scrap paper for catalog stations. This provides good experience for the volunteer and a useful service to the Library. --AL
- 11. Our winter newsletter was mailed in early November to all residents in our district. Major features in this issue are the Children's Renewal Project and our annual One Book, One Community. The former was also shared on our blog and social media, resulting in lots of positive reactions from the Libertyville Moms group on Facebook.

- 12. All staff were migrated to a **new computer profile system**. We've spent the past year testing and refining settings for this major upgrade. The goal was to enable staff to log in as themselves on the public desk computers, allowing individual customization at the desk and more secure access to documents and files in Microsoft 365. Previously, staff logged in with generic profiles at the public desks because profiles took a very long time to load. Our IT vendor was able to recommend a product which loads profiles differently and cuts down login/logout times to under a minute. The feedback so far is very positive.

We have migrated Outlook email and calendar from an on-premises mail server into the Microsoft 365 platform reducing the need for an on-premises mail server and fully integrating mail and calendar into the rest of our 365 services. We are still wrapping up some final steps in these projects, but I am very excited they are concluding and staff have a fast, secure, and upto-date computer experience no matter what computer they are working on. -- NG





RESOLUTION AUTHORIZING SPECIALTY VEHICLE SERVICES TO FINALIZE DESIGN FOR NEW OUTREACH VEHICLE AND PROCEED TO PROCUREMENT PHASE

- **WHEREAS**, the Board of Library Trustees ("Board") of the Cook Memorial Public Library District ("Library") approved a four-year Strategic Plan on December 22, 2022, based on valuable community input; and
- **WHEREAS**, among the key goals of the Strategic Plan are to (1) "identify the most effective and sustainable outreach vehicle(s) to further serve our community needs," and (2) "incorporate renewable energy initiatives and clean technologies in future building repairs and replacements;" and
- **WHEREAS**, the FY 2025 budget allocated funds to engage a consultant for the purpose of identifying an energy-efficient outreach vehicle to replace the Library's 21-year-old Bookmobile; and
- **WHEREAS,** the Resources, Services, and Long-Range Planning ("Committee") met on five occasions in 2024 on January 23, April 2, August 27, October 10, and November 7 to discuss vehicle replacement options, including the last three with consultant Specialty Vehicle Services ("Consultant"); and
- **WHEREAS**, through thoughtful planning and careful budgeting over the past several years, the Board has reserved \$500,000 to fully fund the purchase of a new Outreach vehicle; and
- WHEREAS, at their meeting on November 7, 2024, Committee members unanimously recommend that the Board direct the Consultant, in coordination with Library staff, to finalize the design of a 27-foot gasoline-powered Winnebago 425S cutaway-style vehicle with a Ford E-450 chassis, including a stationary battery power system with inverter and battery bank, at an estimated cost of \$345,000 to \$360,000 as detailed in Exhibit A.
- NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Cook Memorial Public Library District:
- **Section 1**: The Board directs Library staff to work with Consultant to finalize the design of the new Outreach vehicle as detailed in Exhibit A.
- <u>Section 1</u>: The Board authorizes a \$3,600 payment to Specialty Vehicle Services for procurement services, as detailed in Exhibit A, with the objective of obtaining multiple competitive bids for the new Outreach vehicle.
- <u>Section 2</u>: Upon completion of the procurement phase, the Board will review an analysis summary and bid recommendation from Consultant at a future meeting to determine whether to proceed to the final construction phase.

Please accept this revised document as my professional recommendations for your new outreach vehicle based on our recent meeting and discussions. The goal of this document is to outline the general vehicle configuration we have determined will best suit the goals, desires, and environmental/operational concerns surfaced.

BASE VEHICLE

Based on your unique needs we are recommending a Winnebago 425S cutaway style vehicle based on the Ford E-45O chassis as your base vehicle. The main benefits of this style of vehicle are flat floor (no wheel wells), low entry height, fuel efficiency, maneuverability, and ease of driving. This shell is available to all potential conversion vendors and offers a potentially timely delivery. I believe this type of vehicle will accommodate the maximum number of desirables for this part of the project.
